Your Request for Correction (RFC) now pending with the National Institute for Standards and Technology (NIST) was supplemented with an additional filing with NIST on or about March 29, 2007. I assume that supplement will be posted on your website, along with this memorandum. You filed the supplement in order to call attention to an undisclosed apparent conflict of interest that has a direct bearing upon your assertions that Directed Energy Weapons (DEW) were a causal factor in the destruction of the World Trade Center (WTC) on 11 September 2001.

You have discovered that Applied Research Associates, Inc. (ARA) is not only a major NIST contractor in the clean-up of the WTC site, post 9/11/01, as well as a major contractor for NIST in the preparation of the NCSTAR 1 report series, that your RFCs pertain to, there's more.

ARA is also at the very epicenter of the development of Directed Energy Weapons.

DEW may be the very core of ARA's business, with all other business matters being of secondary importance to ARA.

That information was not disclosed to the public by NIST to our knowledge.

One example serving to illustrate the centrality of ARA to the development of Directed Energy Weapons is the following statement from ARA's website:

"Directed Energy Award: ARA was recently recognized at a directed energy symposium in Washington, D.C. as a Founding Sponsor of the Directed Energy Professional Society (DEPS). DEPS was founded in 1999 to foster research and development of directed

energy technology for national defense and civil applications through professional communication and education."

The very first article in the newsletter, published in the year 2000, starts with the declaration:

"Lasers in space, lasers in the stratosphere, lasers on and over the battlefield - we're at the beginning of an evolutionary new wave of weaponry. Highly precise, long range and primarily defensive in application, high energy lasers are emerging as key components in the military planner's options for defense against intercontinental ballistic missiles, theater ballistic missiles, overland and anti-ship cruise missiles and short-range rockets.

One of the newest concepts is the Airborne Tactical Laser (ATL), which is seeking to join the Space Based Laser (SBL) and the high altitude Airborne Laser (ABL) in moving from laboratory technology validation to government-sponsored concept demonstration and ultimately to operational capability."

Written in 2000.

A third entity that needs mentioning is the US Air Force

Directed Energy Directorate:

"The Air Force Research Laboratory's Directed Energy Directorate develops high-energy lasers, high-power microwaves, and other directed energy technologies for the United States Air Force and the Department of Defense. The Directorate is also involved with advanced optics and imaging technologies to improve the nation's ability to precisely project these directed energies at the speed of light anywhere, at any time and with graduated intensity."

A fourth entity requiring mention here is the **Air Force Institute of Technology's Center for Directed Energy** that supports Air Force and DoD agencies in transitioning high energy lasers and high power microwaves to the battlefield through vigorous scientific and engineering research, graduate education programs, and diverse consulting activities. The Institute first developed a high energy laser program at the request of General Donald Lamberson in 1970. This facility is located at Wright – Patterson Air Force Base.
